THE PROGRAMS

Golden visa programs from different EU countries grant immediate residency visa or even citizenship directly to foreign investors against a lump sum investment, no less than €250,000 in real estate, or in business & commerce. Usually there is no requirement to live in the country .

The main criteria for destinations:

- Costs: investment volume and fees
- Time: time for the application and to get a citizenship
- Mobility: where you can travel
- Location: live quality, advantages, economic and social situation at the destinations
